

Plan International Liberia Call for Expression of Interest

INVITATION FOR EXPRESSION OF INTEREST (EOI) TO SERVE AS SERVICE PROVIDER (SP) FOR THE LIBERIA 2021 INSECTICIDE TREATED NETS (ITNs) MASS DISTRIBUTION CAMPAIGN UNDER THE LIBERIA GLOBAL FUND MALARIA NEW FUNDING MODEL (NFM2) GRANT

The Global Fund is supporting Liberia in the fight against AIDS, TB and Malaria through different grants. For the Global Fund malaria NFM2 grant, Plan International Liberia is a co-principal recipient (PR) to the Ministry of Health. The two PRs are responsible for the implementation of the current malaria grant running from July 2018 to June 2021. Plan International Liberia in the grant implementation is responsible for the community component targeting hard to reach communities in four counties where Plan is directly implementing integrated community case management (iCCM) activities. In addition, Plan International Liberia in collaboration with the MOH and other partners is responsible for the Liberia 2021 Global Fund supported ITN mass distribution campaign in the malaria grant across all the 15 counties in Liberia. The actual ITN distribution is expected to commence in April 2021. Preparations leading to the actual distribution which started a long time ago is ongoing with some pre-distribution activities.

Plan International Liberia will be responsible for direct implementation of the ITN campaign in three (3) counties where Pan International Liberia is implementing iCCM activities (i.e. Bomi, Nimba and Margibi). Implementation of the ITN campaign in the remaining 12 counties in Liberia will be done through service providers (SPs) i.e. selected organizations with capability to do so.

It is against this background that Plan International Liberia in collaboration with the MOH invites qualified organizations to submit Expression of Interest (EOI) to serve as Service Providers (SPs) for the Liberia 2021 ITN mass distribution campaign in the remaining 12 counties (i.e. Monsterrado, Grand Bassa, Bong, Gbarpolu, Grand Cape Mount, Maryland, Grand Gedeh, Grand Kru, River Gee, Lofa, RiverCess and Sinoe). The period of engagement for providing the required services is December – June 2021. The Service provider that will undertake the 2021 ITN mass distribution in the assigned county(ies) will be responsible for;

- · recruiting and training community health volunteers;
- · undertaking household registration;
- ensuring proper storage and security of ITN at district and community levels;
- ensuring timely and secured transportation of ITN from district to community storage or distribution points and distribution of ITNs as per assigned counties (see table below with allocated ITN per county):
- ensuring full accountability and timely reporting (financial, logistics/stores and distribution data) of all
 assigned ITN mass distribution campaign activities covered in assigned county(ies)
